ARTICLE I  
NAME

The name of the Corporation is: BREWSTER CLEANING, INC., a domestic corporation, which is not a member of any affiliated group.

ARTICLE II  
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 3315 Acapulco Drive, Riverview, Florida 33569.

The principal mailing address of this corporation shall be: P.O. Box 1074, Ruskin, Florida 33570.

ARTICLE III  
PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of residential, commercial and new construction cleaning; and
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
