

ARTICLES OF INCORPORATION

OF

BREWSTER CLEANING, INC. A Florida Corporation



ARTICLE I NAME

The name of the Corporation is: BREWSTER CLEANING, INC., a domestic corporation, which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE
