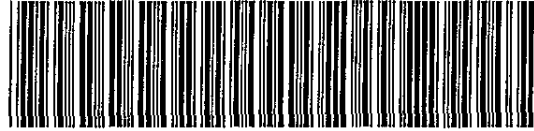

INFORMAL ACTION OF DIRECTORS**


If all the directors separately or collectively consent in writing to any action taken or to be
