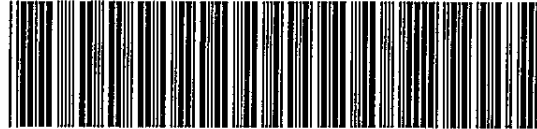

ARTICLE I - NAME OF CORPORATION

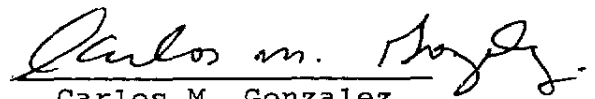
ARTICLE IX - AMENDMENT TO ARTICLES

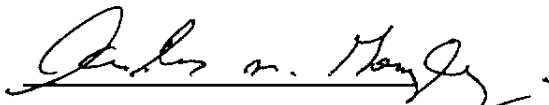
