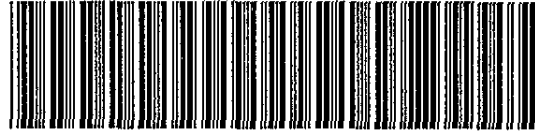

ARTICLES OF INCORPORATION
OF

Uncle Lou's Entertainment Hall, Inc.
A Florida Profit Corporation

(Pursuant to Chapter 607 and/or 621, Florida Statutes)

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

1. **Name.** The name of this corporation is Uncle Lou's Entertainment Hall, Inc.

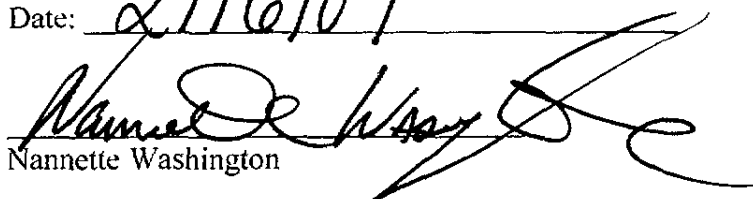

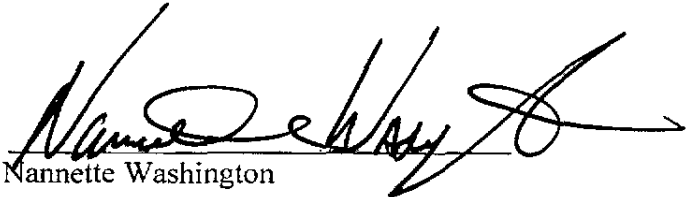
