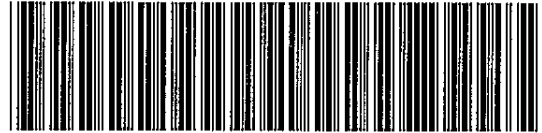

ARTICLE I - NAME


ARTICLE XI - EFFECTIVE DATE
