ARTICLES OF INCORPORATION

The undersigned incorporation for the purpose of forming a corporation under the Florida Buriness

Corporation Act, Chapter 607 of the Florida Statutes, hereby adopt the following Articles of Historporation.

ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is T & T Tree Trimming, Incorporated hereinafter referred to as the "Corporation".

ARTICLE VI: PREEMPTIVE RIGHTS

The Corporation elects to have preemptive rights. Every shareholder, upon the sale for cash of any new or reissued stock of the Corporation, shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT
