

THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE  
FLORIDA GENERAL CORPORATION ACT, adopt the following Articles of Incorporation:

ARTICLE ONE  
NAME

The name of the corporation is DOCTORS AND SERVICES / MEDICOS Y SERVICIOS PUBLISHING INC.  
"Doctors and Services" is a translation to English of the Spanish version of the name "Medicos y  
Servicios."

ARTICLE TWO  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE  
PURPOSE

The Corporation is formed for the purpose of engaging in publication of a periodical for  
advertising of medical and related services. Additionally, the corporation may transact any and  
all other lawful business for which corporations may be incorporated under the Florida General  
Corporation Act.

ARTICLE FOUR  
CAPITAL STOCK

The aggregate number of shares that the Corporation has authority to issue is 1000, all of which  
shall be common shares with no par value.

ARTICLE FIVE  
PREEMPTIVE RIGHTS IN PROPORTION TO SHARES

Each shareholder shall have preemptive rights only in the portion of shares being issued or sold  
equal to the proportion that the number of shares then held by the shareholder bears to the total  
number of shares in the same class then outstanding.

ARTICLE SIX  
REGISTERED OFFICE - PRINCIPAL OFFICE - MAILING ADDRESS
