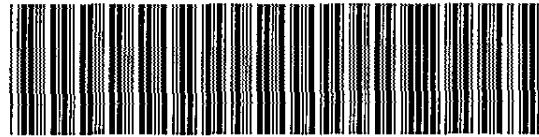

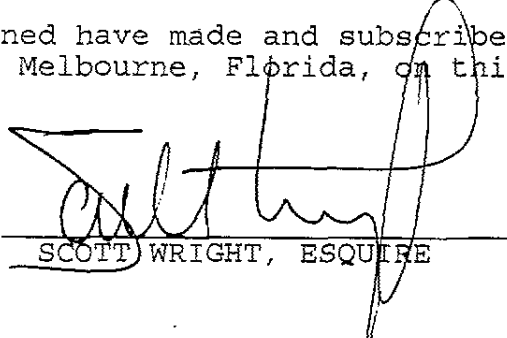
ARTICLE VIII. INDEMNIFICATION

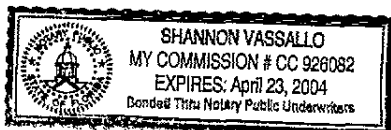

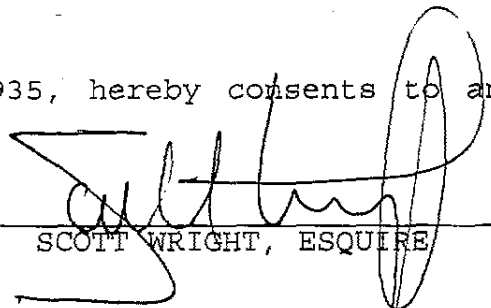
