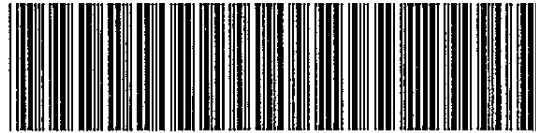

CORPORATE NAME**

**ARTICLE II
PURPOSE**
