ARTICLE OF INCORPORATION

OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of the incorporation shall be:

ARTICLE II

NATURE OF BUSINESS

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any or all lawful activities or business permitted under the laws of the United States, the States of Florida or any other state, country, territory of nation and herein mentioned, as fully and to the same extent as natural persons might do, including, but not limited to, the following:

To elect or appoint officers and agents of the corporation and define their duties and fix their compensation;

To make and alter bylaws, not inconsistent with its article of incorporation or with the laws of this

state, for the administration;

To make donations for the public welfare or for charitable, scientific, or educational purpose;

To transact any lawful business which the shareholder shall find will be in aid governmental policy;

To manufacture, purchase or otherwise acquire, and to own mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal with goods, wares, merchandise and other personal and real property of every class description whatsoever;

To acquire, hold, own, dispose of and generally deal in grants, concessions, franchises, and contracts of every kind, to cause to be formed, to promote and to aid in any way in the formation or any corporation, domestic or foreign;

To act as financial, business and purchasing agent for domestic and foreign corporations, individuals, partnerships, association, state governments and other bodies:

To have one or more offices, conduct its business and promote the object within and without the state of Florida, in other State, the District of Columbia, the territories, possessions and dependencies of the United State, and in foreign countries, without restriction as to place or amount;

To do all and everything necessary and proper for the accomplishment of any of the purpose or the attainment of any of the objects, or the furtherance or any of the powers enumerated in these articles of incorporation or any amendment hereof, necessary or incidentate to the protection and benefit of the corporation, as principal agent, director, trustee or otherwise and, in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objects, or the furtherance or such purposes or objects of the corporation, whether or not such business is similar in nature to the purpose and objects as set forth in these

Articles of Incorporation or any amendment hereof;

The foregoing paragraphs shall be constructed and enumerated both as objects and powers of the corporation, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers this corporation.

ARTICLE III

CORPORATE CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100.00) shares of common stock, each share having the par value of ONE DOLLAR (S 1.00).

- i. All holders of shares of common stock shall be identical with each other in ever respect and the holders of common shares shall be entitled to have unlimited voting rights on a shares and be entitled to one vote for each share on all matters on which Shareholders have the right to vote;
- ii. All holders of shares of common stock, upon the dissolution of the Corporation,
 Shall be entitled to receive the net assets of the Corporation;
- iii. No holder of shares of common stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature; provided, however, that the Board of Director (s) may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the Board of Director (s) may deem advisable in connection with such issuance;
 - iv. The Board of Director (s) of the corporation may authorize the issuance from time

to time of shares of its stock of any class, whether now or hereafter authorized, or securities convertible into shares of its stock of any class, whether now or hereafter authorized, for such consideration as the Board of Director (s) may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in the bylaws of the Corporation;

v. The Board of Director (s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

ARTICLE VII

PRE-EMPTIVE RIGHT

Every shareholders, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which it already holds, shall have pre-emptive right to purchase its prorate share thereof, (as nearly as may be done without the issue of fractional shares), at the price at which it is offered to others.

<u>ARTICLE VIII</u>

<u>INDEMNIFICATION</u>

The corporation, upon a majority vote of the directors and shareholders, may indemnify a director, officer, employee or agent of the Corporation against any and all suits, claims, or judgments, including attorneys fees and costs, to the fullest extend permitted by law.
