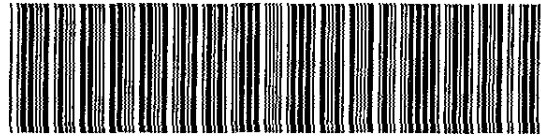

**ARTICLE I.**

**NAME**

The name of the corporation shall be: D & B Vanguard Investment, Inc.

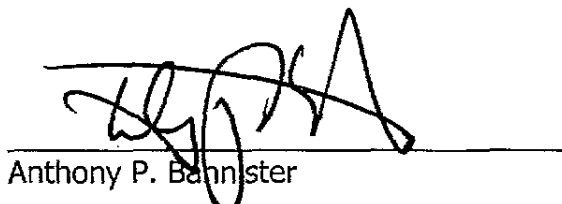
The powers to adopt, alter, amend or repeal bylaws will be vested in the Board of Directors and the shareholders.
