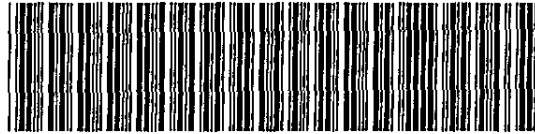



ARTICLES OF INCORPORATION
OF

THE ABERDEEN GROUP, CORP.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is THE ABERDEEN GROUP, CORP.

ARTICLE II

The existence of the Corporation shall begin on filing these articles with the Secretary of State of the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 5345 Pinebark Lane, Wesley Chapel, FL 33543.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 
