ARTICLES OF INCORPORATION

OF

LCF CONSULTING, CORPORATION

We, the undersigned, in order to form a corporation under and pursuant to the provision of the Laws of Florida for the purposes set forth below, hereby subscribe to these Articles of Incorporation.

I

The name of the corporation shall be LCF CONSULTING, CORPORATION.

The purpose and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- A. To do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.
- B. To purchase for investment and resale, and to traffic in land, property, houses and buildings and other property of any nature. To create, sell and deal in freehold and leasehold ground rents. To make advances upon the security of land or houses or other property. To deal in any manner with real and personal property. To manufacture, buy, sell, import, export, install, and repair. To write grants and proposals, execute contracts, develop software, develop multimedia presentations for others, train personnel in various areas of expertise.

- C. Also, to draw, make, accept, endorse, discount, execute, and issue promissory notes, bills of exchange, and other negotiable instruments, including bonds, debentures, or other obligations of this corporation, whether secured by mortgage pledge, or otherwise, or unsecured, for money borrowed, or in payment for property purchased or acquired, or for other lawful objects.
- D.
