The undersigned, for the purpose of forming a corporation for profit integrated away plorida, hereby adopts the following Articles of Incorporation:

Article I

Name

The name of the corporation is Elbanna Enterprise Nine, Inc. and the address of the principal office and mailing address of the corporation is at 1807 Sea Pine Lane, Orange Park, Florida 32073.

Article II

Duration

This corporation shall exist perpetually.
