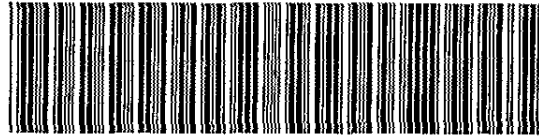

**ARTICLE I**

The name of the corporation is AA Welding & Metalworks Inc. The street address of the initial registered office of this corporation is 2459 Cheney Highway #10 Titusville, FL 32780. The name of the initial registered agent of this corporation at that address is Wilmot Harris Paxton.

**ARTICLE II - DURATION**

The corporation shall exist perpetually, commencing at the time of filing these articles with the state of Florida.
