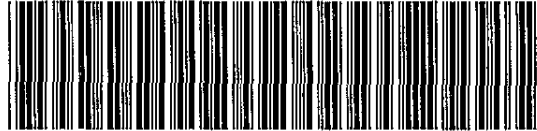

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

**ARTICLE I**

The name of this corporation shall be: Cartwright & Wipert Builders, Inc.

**ARTICLE II**

The duration of the corporation shall be perpetual.

**ARTICLE III**


## ARTICLE VI
