

ARTICLES OF INCORPORATION OF K LIMO & TAXI INC.



ARTICLE I NAME & ADDRESS:

The name of this corporation is K LIMO & TAXI INC. and the address is 3354 SW 154 COURT, MIAMI, FLORIDA 33185.

This corporation is to exist perpetually and it shall commence its existence on the date of filing of the Articles of Incorporation with the Secretary of the State of Florida.

Shares may not be issued until the full amount of the consideration for which shares are to be issued shall have been received by the corporation, such shares shall be deemed to be fully paid and non-assessable.
