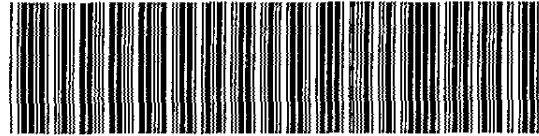

The name and address of the incorporator of this corporation is Johannes Hendrik Meermann, 26211 N. State Road 121, Alachua, Florida 32615.

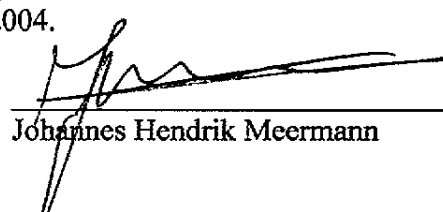
ARTICLE VIII - BY-LAWS

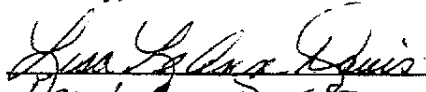

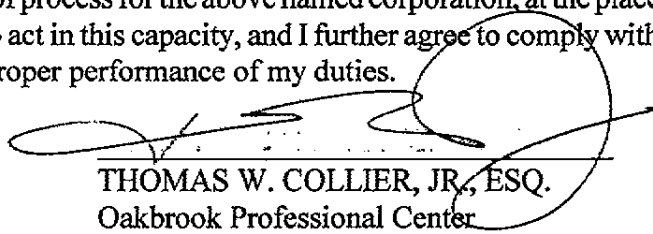
