Articles of Incorporation of TOOLTEK USA., INC.

THE UNDERSIGNED, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to this Article of Incorporation.

ARTICLE ONE - NAME

The name of the corporation is TOOLTEK USA., INC.

This corporation affiliated with: METALS OF BAHRAIN W.L.L., whose business address is P.O.Box 54299 State of Bahrain, holding 51% shares of TOOLTEK USA., INC., M/S ALEX ENTERPRISES, whose business address is 3/25 MG Ganga Vihar, KDA Colony, Jajmau Kanpur 10, India and TOOLTEK W.L.L., whose business address is 1072 Road 5141 Block 951 Askar, State of Bahrain.

ARTICLE TWO - PURPOSE

The general purpose of the business and objects and purposes proposed to be transacted by the Corporation and the powers and privileges to be exercised by it shall include all powers that are given to bodies corporate under the Statutes of the State of Florida, as the same may exist and may be amended from time to time

ARTICLE THREE - CAPITAL STOCK

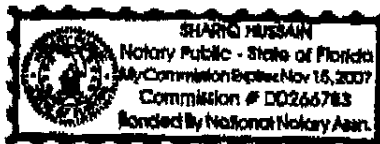
