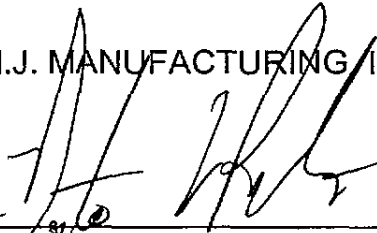
SECOND: The date of the adoption of these Articles of Dissolution is June 18, 2004.
