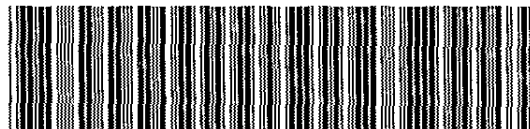

**ARTICLE I NAME**

The name of this corporation is C & W HOME IMPROVEMENT, INC.

**ARTICLE II DURATION**

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

**ARTICLE III PURPOSE**

This purpose of this corporation shall be to engage in the building, remodeling and construction of homes and other structures, and to do any lawful act concerning any, or all lawful business for which corporations for profit may be incorporated under the laws of the State of Florida and the United States of America..

**ARTICLE IV CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

**ARTICLE V PRE-EMPTIVE RIGHTS**

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

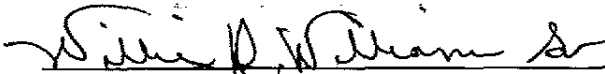
#### **ARTICLE XII AMENDMENTS**
