#### ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, and the person, competent to contract, hereby forms are comporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be: SORGE MEDINA, INC.

# ARTICLE II - PURPOSES
