

The undersigned, acting as Incorporators of a corporation under the Florida Statutes.

ARTICLE I - NAME

The name of the corporation is Image Advertising, Inc.

ARTICLE II - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III - DATE OF COMMENCEMENT


ARTICLE VIII – BYLAWS


