ARTICLES OF INCORPORATION OF 4 GROUND CORP.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator, in adopting and filling the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is 4 GROUND CORP.

ARTICLE II

The existence of the Corporation shall begin on February 27, 2004

ARTICLE III
