ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Daniel Feiner, Inc., at 199 Tyler Avenue, Apt. 1, Cape Canaveral, FL 32920 (Principal Office of Registered Agent).

ARTICLE II - DURATION
