#### ARTICLE I NAME

The name of the corporation is All Systems Maintenance & Repair, Inc.

## ARTICLE II DURATION

The duration of the corporation is perpetual.

## ARTICLE III PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

### ARTICLE IV AUTHORIZED SHARES

This may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
