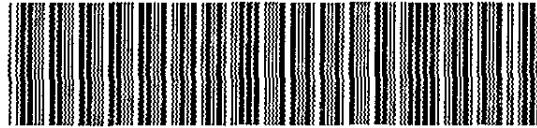

ARTICLES OF INCORPORATION

of

Smart ASP Productions, Inc.

ARTICLE I - NAME

The name of the corporation shall be "Smart ASP Productions, Inc."

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing is "723 Iowa Woods Cr. East Orlando, Fl. 32824-8635".

ARTICLE III - PURPOSE

SECTION V - "Common Stock". Common stock is that which does not have voting rights, but is entitled to dividends as determined from time to time by the Board of Directors.

SECTION VI - All classes of stock shall have an initial par value of Fifty and 00/100 dollars (\$50.00) per share.

SECTION VII - The transfer of stock may occur only upon resolution of the Board of Directors. The Board of Directors may fix any appropriate Resolution to regulate the transfer of stock in the Primary or Secondary markets. Resolutions can occur on an open, or case by case basis.
