# ARTICLES OF INCORPORATION OF INVESTOR RESCOURCES, INC.

The undersigned, for the purpose of forming a corporation for profit pursuant to chapter 607 Florida statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. CORPORATE NAME

The name of this corporation is: Investor Rescources, Inc.

## ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS
