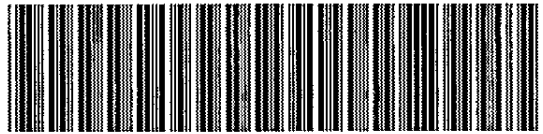

NAME

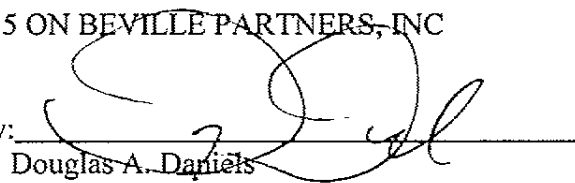

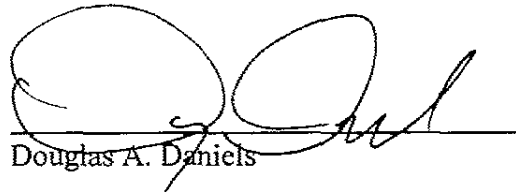
