ARTICLES OF INCORPORATION OF STEPHEN ILARDO PAINTING, INC.

KNOW TO ALL MEN BY THESE PRESENTS: That the undersigned incorporator hereby destifies that he has formed a body corporate under and by virtue of the laws of the state of Florida for the transaction of business with and under the following charter:

Article I: Name -- The name of the corporation shall be Stephen Ilardo Painting, Inc., Inc. with its principal office located at 2902 Park Court, Sanford, Florida 32773.

Article II: Duration – The corporation shall have perpetual existence, unless terminated in the manner prescribed by the laws of the State of Florida.

Article III: Purpose -- The purpose for which the corporation is formed is to engage in any lawful activity or business.

Article IV: Capital Shock -- This corporation is authorized to issue 1000 shares of one dollar (\$1.00) par value voting common stock. Said stock shall be issued only as and when and for such consideration as determined by the incorporator or stockholders.

Article V: Initial Registered Office and Agent —The street address of the initial registered office of the corporation is 2902 Park Court, Sanford, Florida 32773, and the name of the initial registered agent of this corporation at that address is Stephen Ilardo.

Article VI: Incorporator -- The name and address of the person signing these articles is:

Article VII: Management by Stockholders -- The business of the corporation shall be managed, controlled and conducted by the Stockholders of the corporation, as shall be provided for in the bylaws from time to time, and such other officers, if any, as shall be provided for in the by-laws from time to time; provided, however, that as long as the business of the corporation is managed, controlled and conducted by the Stockholders of the corporation, then:

- A. Wherever the context requires, the Stockholders of the Corporation shall be deemed directors of the corporation for purposes of applying the provisions of Florida Statues;
- B. The Stockholders of the Corporation shall be subject to the liabilities imposed by Florida Statues for action taken by Directors;

Such consent shall have the same force and effect as a vote of the Stockholders.
