**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 507.1006 of the Florida Statutes, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the Corporation is CLR OF NAPLES, INC.
2. Article I of the Articles of Incorporation is hereby revoked and the following Article I is inserted in lieu thereof:

**"ARTICLE I.**
