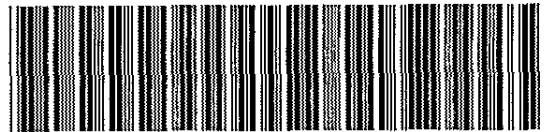

ARTICLES OF INCORPORATION
OF
ACAJOU CORPORATION

The undersigned person, acting as incorporator of a corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is ACAJOU Corporation.

ARTICLE II

The principal place of business and mailing address of the corporation is located at Suntrust Investment Co. S.A., 7 Rue des Battoirs, P. O. Box 568, CH-1211 Geneva 4, Switzerland.

ARTICLE III

The purpose or purposes for which the corporation is organized are to transact any or all lawful business permitted by the statutes of the State of Florida.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock of the par value of One Dollar (\$1.00) each. The corporation shall have the authority to purchase, directly or indirectly, its own shares to the extent not prohibited by the statutes of the State of Florida

ARTICLE V.
