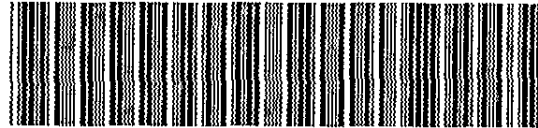

ARTICLES OF INCORPORATION
OF
B-N-C TRUCKING, INC.

ARTICLE I—NAME

The name of this corporation is B-N-C TRUCKING, INC.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE


