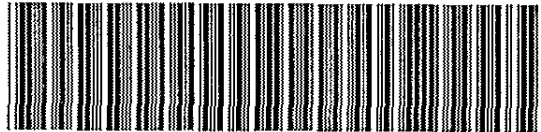



The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I

Name of the Corporation

The name of this corporation is G & D Cleaning of Northwest Florida, Inc.

ARTICLE II

General Purpose

This corporation is organized for the purpose of commercial and residential cleaning services. The corporation may transact any and all other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

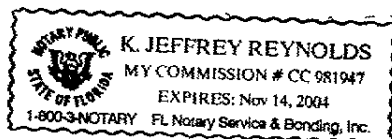
