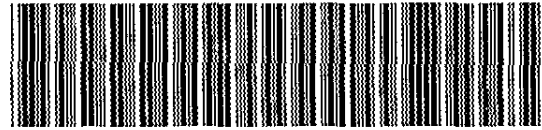

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Good-Wilk Racing, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 2881 Jefferson Street, Marianna, Florida 32446 and the mailing address of the Corporation is P. O. Box 138, Marianna, Florida 32447.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 1,000 common shares, and shall have a par value of \$1.00 each.

ARTICLE FOUR

REGISTERED OFFICE, AGENT, AND ACCEPTANCE

The street address of the initial registered office of the Corporation is 2881 Jefferson Street, Marianna, Florida 32446 and the name of its initial registered agent at such address is Thomas C. Wilkinson. The registered agent, Thomas C. Wilkinson, hereby accepts appointment as registered agent for the Corporation, Good-Wilk Racing, Inc.

PURPOSE OR PURPOSES
