ARTICLES OF INCORPORATION OF

JOHN BUICK P. A.

The undersigned incorporator to these Articles of Incorporation duly licensed to sell real estate under the laws of the State of Florida, adopts these articles to form a corporation under the-Professional Service Corporation Act, F.S. Chapter 621 and other laws of the State of Florida.

Article I Name

The name of this corporation shall be JOHN BUICK, P.A.

Article II Commencement & Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department Of State The corporation's duration shall be perpetual.

Article III Purpose

The professional service corporation is formed to engage in every phase of the sale and rental of real property as a licensed real estate agent in the State of Florida. The corporation may invest funds and own real and personal property necessary for the rendering of professional services.

Article IV Capital Stock
