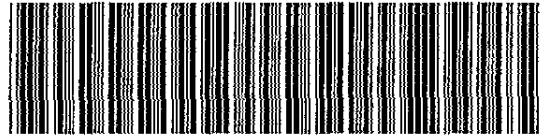

ARTICLES OF INCORPORATION

FRANKAR BUS SERVICE, INC.

ARTICLE I - NAME

The name of this corporation is: FRANKAR BUS SERVICE, INC..

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence at the time of filing these Articles of Incorporation.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permeated under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorizes to issue up to on thousand (1,000) shares of common stock with a par value of \$ 1.00 dollar per share.

ARTICLE V - PREEMPTIVE RIGHTS

ARTICLE IX - INDEMNIFICATION
