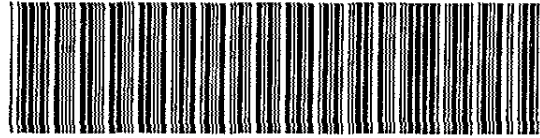



Article ONE.

NAME AND LOCATION OF PRINCIPAL OFFICE

The name of this corporation is AFFORDABLE SOD & LANDSCAPING, INC., and the principal office of said corporation is as follows: 412 13th Street NE, Ruskin, Hillsborough County, Florida, 33570.

Article TWO.

OBJECTS AND PURPOSES


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

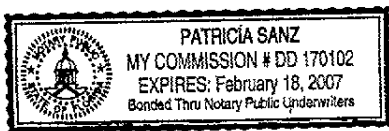
