I, the undersigned incorporator (s), herby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

R&J LIQUIDATORS, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be as follows:

- (a) To operate and transact any legal business, and to buy, sell, lease, rent, hire, and maintain equipment for said business and to do generally all and everything incidental to the operation of said business;
