

ARTICLES OF S CORPORATION OF

COMPTON LANDSCAPING AND CONSTRUCTIONS, INC.

ARTICLE I

The name of the corporation is Compton Landscaping and Construction, Inc. (hereinafter called the "S Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is: 6464 Magee Cir. Orlando, Florida 32818.

ARTICLE III

The capital stock authorized, per value thereof, and the characteristics of such stock shall be as follows:

The corporation shall hold a special meeting of shareholders only:
