ARTICLES OF INCORPORATION OF REICHLE ROATAN USA CORP.

TALLAHASCEE, FLORING

The undersigned incorporator to these Articles of Incorporation, a Tatural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be REICHLE ROATAN USA CORP.

ARTICLE II.
