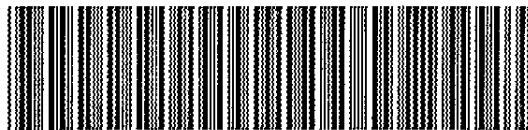

ARTICLE I - NAME

The name of this corporation is HUNTERS RIDGE DEVELOPERS, INC. located at 1682 Hibiscus Blvd., Melbourne, FL 32901.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the date of subscription and knowledge hereof as provided by Florida Statute 607.0203.

ARTICLE III - PURPOSE

#### ARTICLE XIII – AMENDMENT




