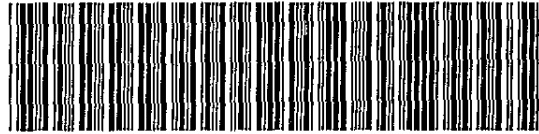

ARTICLES OF INCORPORATION

OF

DJONES ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is: DJONES ENTERPRISES, INC. The corporate address is 1011 CHOKECHERRY DRIVE, WINTER SPRINGS, FL 32708.

ARTICLE II

Duration

The duration of the Corporation is perpetual.

ARTICLE III

Purpose

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. The general nature of the business to be transacted by this corporation shall be any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV
Capital Stock

The aggregate number of shares which the Corporation is authorized to issue is 1000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$.00 per share.

ARTICLE V
Initial Registered Office and Agent

The street address of the initial Registered Office of the Corporation is 1011 CHOKECHERRY DRIVE, WINTER SPRINGS, FL 32708 and the name of its initial Registered Agent at that address is DANIEL E. JONES.

ARTICLE IV
Initial Board of Directors,
Officers and Subscribers

The number of Directors constituting the initial Board of Directors is 1. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The following are the names and street addresses of the person(s) who shall constitute the initial Board of Directors of the corporation, and the person(s) holding office for the first year of the corporation's existence, or until their successors are elected and have qualified, and each of the following named person(s) is subscriber to these Articles of Incorporation.


ARTICLE VII

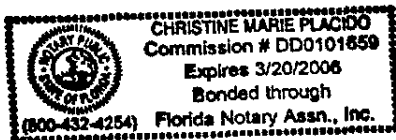
