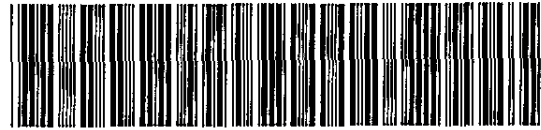

Amendment:

**FIRST:** The name of the corporation is J & J  
Acquisitions, Inc.;

**SECOND:** Article I of the corporation's Articles of  
Incorporation is amended entirely to read as follows:

The name of the corporation is "National Golf Concepts, Inc."

**THIRD:** The foregoing amendment to Article I was adopted and
