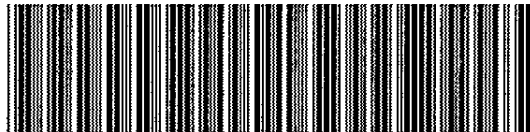

1. Vitaliy Stepanchuk Inc. (the "Corporation"), was incorporated under the laws of the State of Florida effective March 5, 2004, by document number P04000041493;
