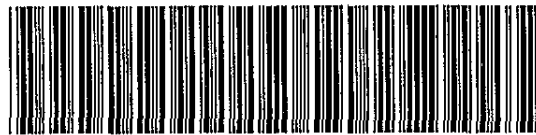

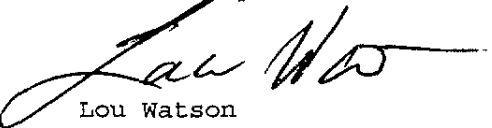

ARTICLES OF INCORPORATION

OF

TPJK INVESTMENTS, INC.

I, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, incorporation: Chapter 607 Florida Statutes, do hereby adopt the following articles of

ARTICLE I

The name of the corporation is TPJK Investments, Inc.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The general purposes for which the corporation is organized are:

1. 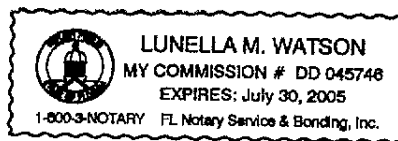
