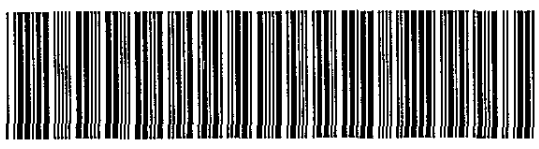

ARTICLE I

NAME

PRE-EMPTIVE RIGHTS


