## ARTICLES OF AMENDMENT OF ANGEL WATCH, INC. OF AMELIA ISLAND

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of ANGEL WATCH, INC. OF AMELIA ISLAND, a Florida corporation (the "Corporation"), and in connection therewith, the undersigned officer, acting upon the authority of the Board of Directors of the Corporation, and upon authority of the holders of a majority of the shares entitled to vote on said amendment hereby set forth as follows:

- The name of this Corporation is ANGEL WATCH, INC. OF AMELIA ISLAND
- The Articles of Incorporation of ANGEL, WATCH, INC. OF AMELIA ISLAND have been amended by deleting Article III in its entirety and by substituting in lieu thereof the following Article:

## "Article III

The maximum number of shares this Corporation is authorized to issue is 1,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote."

- In accordance with Florida Statutes Section 607.1003, the referred to amendment was adopted by the Board of Directors of the Corporation on December 31, 2007 and unanimous written consent to the said Amendment was given on December 31, 2007 by the holders of all of the shares of the Corporation entitled to vote thereon. The number of votes cast for the Amendment by the stockholders of the Corporation is sufficient for approval of the Amendment.
- Upon the filing of these Articles of Amendment by the Department of State, the above referred to amendment shall become effective and the Articles of incorporation of the Corporation shall be deemed to be amended accordingly.
