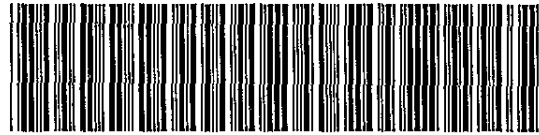



OF

ARTICLE I

CORPORATE NAME

The name of the corporation is MARCO GLASS, INC.

ARTICLE II



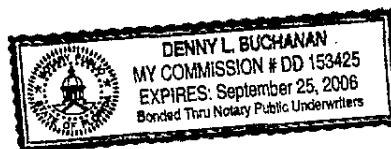
